

The Final Drive Jackpot Market Hog Show Rules
Location: Ware County Agricultural Center
Date: February 6th, 2021

1. Exhibitors from all states will be eligible to show.
2. Any exhibitor ages 4 through 21 will be allowed to enter the show. Pre-club exhibitors must be able to exhibit his/her hog without the assistance of an adult or older exhibitor in the ring.
3. Entries will be limited to the first 150 head of swine entered. Once this number is reached, we will stop accepting entries for the show. If the entries have already been mailed, we will notify the exhibitor and return their entry to them.
4. Exhibitors who are housing pigs in the barn will be given a pen assignment. Our pens are 5' X 5' and the pens will be assigned on first-come, first-served basis as entry forms are received. No tack pens will be provided.
5. Exhibitors may show off the trailer for a \$25 fee per trailer. Due to limited space around the facility, this option will be limited to the first 15 exhibitors that pay the trailer fee. If you are not allotted a trailer spot then pens will be provided for you in the barn and your \$25 will be returned. If this occurs, you will be notified prior to the show date.
6. All entries must be accompanied by current health papers at the time of check-in.
7. All hogs must be tagged, and tag numbers must be included on the entry form. Absolutely no hogs will be accepted without a tag.
8. All Hogs will be shown by weight. Check-In will take place from 7:00 – 9:00 AM on Saturday February 6th, the show will begin at 10:00 AM, or as soon as weight classes have been broken.
9. Showmanship will be broken into grade ranges after the entries have been received. The show will payout 100% of all money collected for showmanship.
10. Show management reserves the right to change, combine or delete classes with insufficient entries.
11. After pigs have been weighed and leave the scales, there will be no changes made. Any changes that need to be made must be made before leaving check-in.
12. Show officials also reserve the right to reject any entries for whatever reasons necessary. Decisions made by show officials will be final.
13. Payout will be determined upon the number of entries.
14. The judge's decision is final in all classes.
15. Only show officials and exhibitors are allowed in the show ring.
16. Exhibitors are responsible for his or her own animal and must assume all associated risk.
17. Ware County BOE and Ware County High School, nor anyone or anybody associated with the show are liable for accidents, injuries, or theft.
18. Bedding will NOT be provided you must bring your own bedding (wood shavings). Straw is NOT allowed.

PUREBRED MARKET HOG SHOW

1. Four (4) purebred market hog breeds will be recognized at The Final Drive Jackpot Market Hog Show: Duroc, Hampshire, Landrace, Yorkshire.
2. A minimum of ten (10) purebred market hogs will be required to constitute a class of purebreds. If the minimum is not met, those animals will show in the crossbred classes.
3. The original registration certificate must be presented at the time market hogs are checked into the show. No copies or duplication of the original registration certificate will be accepted. Registration certificate must be made out in the exhibitor's name only. Farm names will not be acceptable.
4. All purebred animals will show in one class. If entries permit, there could be multiple classes that will then be broken by weight. The winner of this class, or classes, will be eligible to compete in the final drive for Grand and Reserve Champion.
